Tuition and fees are paid at registration. Books are purchased the first day of each quarter. Tuition is based on full-time status. Out-of-state residents pay \$178 per credit hour in tuition, except Jefferson, Gadsden, Leon Counties, and all of Alabama.

As of January 2001, felons are not able to sit for the Medical Assisting Examination unless granted a waiver by the Certifying Board. The waiver could be based on one or more mitigating circumstances listed in the Disciplinary Standards. Disciplinary standards are available in the office of the Southwest Georgia Technical College Medical Assisting Program Director.

If TB skin test is positive or previous TB skin test was positive, must follow-up with a chest x-ray. The physical must contain current information within the last one year.

****** Students are required to have at the beginning of the 2nd semester cohort the following uniform items for lab: watch with a second hand, stethoscope, B/P Cuff, photo ID, lab coat with school patch on left sleeve, and photo ID. Students are required to have at the beginning of the 4th semester cohort the following uniform items for clinicals: (2) two regulation tops with student patch on left sleeve, (2) two pair regulation pans or skirts, (2) two pair support hose or socks, (1) one pair Nursing shoes (white).
